**President (Feinstein):** It was good weekend for UNC sports. PLC's draft vision statement coming soon; town hall will be in UC Ballrooms, Monday 10/14/19 at 10-11:30am. **Provost (Anderson):** Met with Amie, Francie, and Angela last week met to kick off EBS dean search. MCB dean position is posted. Recent meetings with Colorado School of Mines and CSU-Pueblo to discuss areas where our institutions can work together. Hiring discussions underway with deans, with mindfulness of the University's financial position; expected new hires to be approximately 5 positions with possibility to drop to zero.

**Board of Trustees (Fischer):** Meeting to consider support for prop CC; a third of the money collected over the TABOR limit to be used toward higher education. BOT has endorsed Proposition CC.
